

## Hire Agreement

Ergolink can provide ergonomic equipment on a hire before you buy basis for businesses in the Perth metropolitan area.

### Deposit

A \$50 or \$100 deposit is payable on each item before despatch (to be determined on price of unit by Ergolink). The deposit shall be refunded at completion of the hire, if the conditions of the hire are met. The deposit shall be kept if the returned condition of the unit is not as received by the customer.

If the customer chooses to buy the hire unit, the deposit may either be refunded or taken off the price of the unit.

### Damage & Packaging

All hire good must be returned undamaged in its complete and undamaged packaging.

If damaged on hire, Ergolink reserves the right to charge out the full retail price of the item to the customer, of which the Customer would then own the item; or Ergolink reserves the right to retain the deposit, whichever Ergolink deems is most applicable.

### Purchase

If you choose to purchase the item, 50% of the hire fee can be credited off the purchase price, up to a maximum of one month (For Height adjustable desks and sit to stand units please refer to separate hire conditions).

### Chairs

Chairs must be kept in a clean office environment unless otherwise approved by Ergolink.

Chairs that require repairs or cleaning will be billed in full you or your organisation in full (refer to section "Damage and Packaging)

Hard wearing polyurethane chairs are available for factory, warehouse or industrial environments.

### Fees

Hire fees for most items start from \$27.50 per week and range up to \$99.00 per week for more expensive items. For Height Adjustable Desks and sit to stand units please refer to separate hire conditions and fees.

### Ownership

The goods remain the property of Ergolink at all times until purchase of the item under Ergolink conditions is made. Failure to pay for the hire, Ergolink reserves the right to reclaim the item from the Customers premises during business hours.

Failure of payment or arrangement of collection of the item Ergolink may make a claim through the Public and Personal Securities Act (PPSA) on the business or the individual, and or through legal channels.

### Delivery / Pick up

It is the responsibility of the hirer to arrange for pick up and return of the item. Ergolink can arrange for delivery and pick up and normal charges apply.

### Duration of Hire

Hire is for a period of 2 weeks or monthly.

Extensions may only be granted upon discussion with Ergolink.

### Items for Hire

- General office furniture of all descriptions
- Telephone headsets
- Any item in a blister pack

The user agrees to indemnify Ergolink from any injury, loss or damage to equipment, people or data, occurring via the direct or indirect use of the product, including the installation or removal of the product (and including while still at the clients' premises).
