

Hire Agreement

Ergolink can provide some ergonomic equipment on a 'hire before you buy basis' for businesses in the Perth metropolitan area.

Deposit

A deposit is payable on each item before dispatch. The value is determined by the item. The deposit may be refunded at completion of the hire, if conditions are met. Conversely the deposit may be kept if the returned condition of the unit is not as received by the customer. If proceeding to purchase the hire unit, the deposit may be refunded or taken off the price of the unit.

Damage & Packaging

All hire / trial goods must be returned undamaged in complete and undamaged packaging.

If damaged on hire, Ergolink reserves the right to charge the full retail price of the item to the requestor. Ownership will transfer to the requestor, or Ergolink reserves the right to retain the deposit.

Purchase

If you choose to purchase a hired item, 50% of the *hire fee* may be credited off the purchase price for up to a maximum of one months hire (For Height adjustable desks and sit to stand units please refer to separate hire conditions).

Chairs (Limited Selection Available)

Chairs must be kept in a clean office environment unless otherwise approved by Ergolink.

Chairs that require repairs or cleaning will be billed in full to the Requestor.

Hard wearing polyurethane chairs are available for factory, warehouse or industrial environments.

Fees

Hire fees for most items start from \$27.50 inc gst per week and range up to \$99.00 inc gst per week for more expensive items. For Height Adjustable Desks and sit to stand units please refer to separate hire conditions and fees.

Ownership

The goods remain the property of Ergolink at all times until purchase of the item under Ergolink conditions is made. Failure to pay for the hire, Ergolink reserves the right to reclaim the item from the Users premises during business hours. Failure of payment or arrangement of collection of the item Ergolink may make a claim through the Pubic and Personal Securities Act (PPSA) on the business or the individual, and or through legal channels.

Delivery / Pick up

It is the responsibility of the hirer to arrange for pick up and return of the item. Ergolink can arrange for delivery and pick up at normal charges.

Duration of Hire

Hire is for a period of 2 weeks or monthly.

Extensions may only be granted upon discussion with Ergolink.
